## Class and Lesson Contract



**Calendar:** Classes/Lessons run Mid-September (**Starting 2<sup>nd</sup> Tuesday after Labor Day**) through Mid-May, culminating with an end of the year Show Case Recital.

**Class size:** A minimum of four students is needed for a class. Registration is limited and is confirmed on a first-come, first-serve basis. No student will be added to a class roster without fees paid and registration forms complete. If a student misses a class, no make-up lesson is available, however, if a class must be postponed due to instructor's schedule, make-up classes will be offered at an alternative time that same week.

**Tuition payments:** Classes will meet weekly mid Sept though April; there may also be one or two Saturday dress rehearsals prior to the finale showcase at the end of the year. TUITION can be paid in FULL (\$400.00) at registration or in 8 MONTHLY INSTALLMENTS (\$50.00) due on the first class of each month. Payment is considered late as of the 10<sup>th</sup> day of the month and a \$20.00 late charge will be added to all unpaid accounts. If a student needs to withdraw for any reason, a **30-day written notice will be required along with the next month's tuition payment.**

**Early Bird 5% Discount:** Payment in Full by August 31<sup>st</sup> *(All discounts applied before Referral Discount)*

**Family/Multi-Class Discount:** 2 siblings/classes 5%; 3 siblings/classes 10%; 4+ siblings/classes 15% *(All discounts applied before Referral Discount)*

**Referral Discount:** \$10 discount for each class a referee is currently enrolled in. *(Referee can only be claimed by one person)*

All tuition and payments are non-refundable for any reason.

There will be a thirty-five dollar (\$35.00) service charge for all returned checks for any reason.

**Performance Attire:** Each child's Performance Attire will vary according to their role in the production; however, every effort will be made to minimize parents' out of pocket expense for costume attire.
